- Reservations are on a first-come, first-serve basis. Payment is due with application to secure your spot. We will accept one exhibitor per business (i.e. one Tupperware, Avon, etc.)
- The vendor fair fee is **\$40** (one 8' table and 2 chairs in roughly 8' X10' space) OR **\$60** (two 8' tables and 2 chairs in roughly 8' X20' space)
- If you have unique set-up or space requests, contact [susan@grantedtristate.org](mailto:susan@grantedtristate.org) and we will see if we are able to accommodate you.
- A raffle/auction prize valued at \$25 minimum is required upon arrival at the event.
- Electricity is limited and you will need to provide your own power cord.
- Set up begins at 8:30 am. We ask that all vendors be set up and ready to go by 9:45.
- Each vendor is responsible for keeping their own bank.
- If you have a mailing list, website, Facebook page, or other forms of communicating with your customers, we encourage you to promote your participation to this event! We want you to have a great day of sales!
- No early takedowns; it is not fair to your fellow vendors or the people who have come out to shop this event.
- We will not hold any spaces without payment.
- Each vendor will be responsible for any loss of property or injury.
- Cash and carry is permitted. All vendors are responsible for distributing orders and product.
